THE PROGRAM AND CONDITIONS OF THE OPENED CONTEST ON LAYOUT OF BURKHAN CAPE AND NEARBY LOCATION

1. GENERAL CONDITIONS

- 1.1. The following thesis sets goals, main principles and organizational orders of the contest on Burkhan Cape and nearby location's layout, which is a natural park and an object of cultural (archeological) heritage of the Russian Federation "Burkhan".
- 1.2. The customer of the contest is the Administration of Khuzhir, Irkutsk region.
- 1.3. The sponsors are:
 - Charity foundation "Give Life to the Planet" (main sponsor)
 - Administration of Khuzhir, Irkutsk region
 - Irkutsk regional department of the public organization "Russian Designers Unity"
 - Irkutsk regional department of the public organization "Russian Architects Unity"
- 1.4. All information is provided on the website of the contest (www.burkhan-project.ru) and the charity foundation "Give Life to the Planet" (www.ppjizn.ru)

2. INTRODUCTION

- 2.1. Burkhan Cape is located in the central part of the West coast of the biggest lake Baikal.
- 2.2. On the territory of Burkhan Cape there is an object of cultural (archeological) heritage of the Russian Federation "Burkhan".
- 2.3. The object of cultural (archeological) heritage of the Russian Federation "Burkhan" assembles an archeological complex "Shaman Cape" with a certain territory.
- 2.4. Nearby territories have a use for tourism and touristic infrastructure according to the Regulations on the usage of the land asserted by the government of Khuzhir on 02.07.2013 № 37.
- 2.5. Shaman's Rock and Burkhan Cape are a sacred place for many nations.
- 2.6. Shaman's Rock (the Shamanka) has become one of the most famous and attractive Baikal's landmarks.
- 2.7. More than 95% of the whole territory offered for the layout is under a huge anthropogenic load, following ecosystem's dysfunction, destruction of the cultural heritage's objects and an inappropriate behavior in the sacred place.

3. TASKS AND GOALS OF THE CONTEST

- 3.1. Goals of the contest: attraction of creative professional people from Russia and other countries to solve the problem of saving peculiar nature territories; obtainment of the project on Burkhan Cape and nearby location's layout; support of social, cultural, educational, commercial organizations and private individuals.
- 3.2. Tasks of the contest:
 - Creation of concepts on the layout of Burkhan Cape and subsequent realization of them;
 - Preservation of historical and cultural importance of Burkhan Cape according to the local traditions;

- Usage of the contest's materials to develop the territory as a center of tourism on the Olkhon island;
- Creation of the system of touristic awareness about a decent behavior in the sacred places;
- Attraction of skilled practicing architects, designers and majoring students;
- Creation of an effective cooperation of the government, educational, cultural and commercial organizations of the country.

4. CONDITIONS OF THE PARTICIPATION IN THE CONTEST

- 4.1. Categories of people who can take part in the contest: practicing architects, designers, majoring students older than 18 years old, citizens of the Russian Federation (or other countries) with all of the required documents, state and commercial organizations registered at the territory of Russia or other countries.
- 4.2. Participation in the contest is free of charge.
- 4.3. Registration of the participants is held on the contest's website. All registered participants will get a confirmation and a personal number (combination of six numbers to use on the materials of the contest). In case of need, the participant is able to get additional instructions.
- 4.4. Prepare an application form from the additional documents of the contest.
- 4.5. Sent materials are not refundable.
- 4.6. Customers of the contest have a right to use the materials at their discretion for the exhibitions, mass media publications and other events with the obligatory indication of authorship but without any additional agreement with the authors of the materials. All other authorship rights are kept by the participants. In case of need, customers of the contest have a right to change the materials in order to use and exhibit them further.
- 4.7. The contest is divided into two parts:
 - 1- creation of the concepts with the following choice of 10 best projects by the expert judges.
 - 2 revision and rework of 10 best projects by the authors and the following choice of the contest winner.
- 4.8. Customers of the contest do not compensate any financial expenses connected with the application form, arrival and accommodation of the participants during the awards ceremony.
- 4.9. Application form submission means that the participant is fully agreed with the conditions of this document.
- 4.10. The official language of the contest is Russian.

5. TECHNICAL TASK OF THE CONTEST

5.1. Technical task of the contest on Burkhan Cape and nearby location's layout is described in "Technical Task" document on the contest's site (burkhan-project.ru).

6. TERMS OF THE CONTEST

- 6.1. Contest announcement 01.01.2017.
- 6.2. Registration of the participants on the contest's website from 01.01.2017.
- 6.3. Completion of the contest projects 31.03.2017 at 23:59 (Moscow Time Zone).

- 6.4. Placement of the contest projects on the official site from 01.04.2017.
- 6.5. Results of the first part of the contest 15.04.2017.
- 6.6. Contest projects exhibition (time and place will be announced on the official website).
- 6.7. Announcement of the second part of the contest for 10 best projects from 15.04 to 16.04.2017.
- 6.8. Seminar "Nature Park and the object of cultural heritage Burkhan Cape" (time and place will be announced).
- 6.9. Start of the acceptance of the projects 15.04.2017.
- 6.10. Finish of the acceptance of the projects 31.05.2017 till 23:59 (Moscow Time Zone).
- 6.11. Results of the second part of the contest by the expert judges. Public vote "People's Choice Award" 12.06.2017.
- 6.12. Awards ceremony, briefing for mass media sources (time and place will be announced).
- 6.13. Release of the contest projects' catalogue.

7. ORDER OF THE CONTEST, RESULTS AND PRIZES

- 7.1. The contest is a public and opened event held in two parts. All information will be announced on the contest's official website. Projects sent till 31.03.2017 can take part in the contest (1st part).
- 7.2. All projects must be sent through the e-mail to info@burkhan-project.ru.
- 7.3. The participant guarantees that the information given to the contest is reliable.
- 7.4. The participant guarantees that the given projects do not violate any authorship rights.
- 7.5. Authors of 10 best projects will be offered to participate in the second part of the contest.
- 7.6. All winners of the first part of the contest get the following prizes:
 - food and lodging for 7 days on the Olkhon island, transit Irkutsk-Khuzhir-Irkutsk.
 - the period will be offered to the participants by the main Sponsor (April-May 2017).
- 7.7. Winners of the contest will be chosen by the majority of Expert judges. Winners get the following prizes:

- 7.8. All participants get Diplomas of Participation.
- 7.9. Besides main prizes the participants can get some additional prizes and diplomas established by the sponsors.
- 7.10. Winner of the contest will be invited to work on and develop the project as the Main designer.
- 7.11. The Main designer must provide the sponsors with the following information: work as the main architect of a project, released or developed projects during the last five years.
- 7.12. All contest projects will be included in the special released catalogue.
- 7.13. All contest projects will be published on the official website with the links on the authors.

7.14. Information about the contest's results will be announced on the official websites.

8. CREATION AND WORK OF THE EXPERT JUDGES

- 8.1. With the purpose of choosing the winners of the contest the expert judges are: Russian Designers Unity, Russian Architects Unity, professors of ISTU, artists, historians, sponsors of the contest, PR-specialists and others.
- 8.2. The chairman and the expert judges are decided by the customers of the contest.
- 8.3. The expert judges independently determine regulations of their work.
- 8.4. The expert judges have a right to reject projects if they do not correspond the rules of this document.
- 8.5. The expert judges choose the winner of the contest by the majority of votes after evaluation of the contest projects and compile a protocol.
- 8.6. The expert judges have a right not to give a prize if the project does not correspond the rules.
- 8.7. By the decision of the expert judges special prizes can be given.

9. EXCLUSIVE PROPERTY AND ALLIED RIGHTS, INCLUDING AUTHOR'S RIGHTS

- 9.1. All materials given for the Contest become property of the Main Organizer of the Contest.
- 9.2. Authorship rights on the design decisions presented in the Contest projects are protected by standards of the Russian legislation and the international legal acts. The author of the contest work reserves an authorship right according to the legislation of the Russian Federation.
- 9.3. The main Organizer has the right to use the architectural concept (Contest work) for the further design and realization.
- 9.4. Organizers of the Contest have the right to demand from the Winner of the Contest of entering of reasonable changes into the design decisions reflected in the architectural concept
- 9.5. Organizers of the contest have the right also to make changes to arrangement elements, with the use of several works for creation of the specification to design and to carry out in the future reconstruction of an object
- 9.6. Organizers have the right to use the separate solutions proposed by other participants of the Contest
- 9.7. Organizers have the right for the first publication of design offers and have the right to carry out the similar publication without paying extra fee to participants of the Contest.
- 9.8. The participant of the Contest and the Customer have the right to use the material created within the Contest for the presentations of the general character, brochures, articles, advertisements, exhibitions, fairs, etc.
- 9.9. The customer undertakes to use given material only with a mention of a name of the Participant of the Contest
- 9.10. The customer of the Contest has the right for the publication of the presented work on Internet resources, and also in materials of the press, printing materials, telecasts and exhibition actions without additional coordination with the Participant
- 9.11. The main organizer has an option of the general designer of the project with participation of the author and without participation of the author, in case of his

- refusal of further work, by joint decision of representatives of all customers of the contest.
- 9.12. The project is considered to be coordinated with the author and the General designer, in case of existence on the project documentation of the General designer the signature of the author of Contest work. If that consent is absent from the author, the Main organizer has no right of development of the project by forces of other designers and its realization.
- 9.13. The main organizer has the right to transfer to the Customer all contest materials, and also the project documentation for the purpose of implementation of the project of arrangement of the Cape of Burkhan and nearby territories
